**STIPULATION AND ORDER EXTENDING DEADLINE FOR AIRPORT OPERATOR
DEFENDANTS TO FILE ANSWERS**

WHEREAS, Massachusetts Port Authority, Metropolitan Washington Airport Authority, the City of Portland, Maine, and the Port Authority of New York and New Jersey (the "Airport Operators") are named as defendants in the individual actions consolidated herein and listed on Exhibits A, B, C, and D.


WHEREAS, the individual actions against the Airport Operators were subsumed in Plaintiffs' Flight 11 Master Liability Complaint, Plaintiffs' Flight 175 Master Liability Complaint, Plaintiffs' First Amended Flight 77 Master Liability Complaint, Plaintiffs' Flight 93 Master Liability Complaint, and Property Plaintiffs' First Amended Master Liability Complaint (the "Master Complaints").

WHEREAS, the Airport Operators filed motions to dismiss pursuant to Rule 12(b)(6) of the Federal Rules of Civil Procedure on January 17, 2003 and February 7, 2003.


WHEREAS, the Court issued an Order on May 5, 2003 denying the motions to dismiss without prejudice as premature.

WHEREAS, the deadline for the Airport Operators to file answers to the Master Complaints under Rule 12(a)(4)(B) of the Federal Rules of Civil Procedure is May 19, 2003.

NOW THEREFORE, the undersigned agree, subject to this Court's approval, that the deadline for the Airport Operators to file answers to the Master Complaints as well as notices of adoption for the individual complaints listed on Exhibits A, B, C, and D shall be extended from May 19, 2003 until June 13, 2003.
